Purpose

At Bushey Heath Primary School, we are committed to fostering environmental responsibility and sustainability within our school community. We believe it is essential to educate our pupils on the importance of protecting our environment for future generations and to lead by example through sustainable practices in our daily operations.

Aims

Our Environmental Policy aims to:

- Promote environmental awareness among pupils, staff, and the wider community.
- Reduce our carbon footprint and manage resources efficiently.
- Encourage sustainable behaviours both in and outside of school.
- Comply with relevant environmental regulations and best practices.

Key Principles

- 1. Waste Management
- Reduce, reuse, and recycle wherever possible.
- Minimise waste generated by the school by avoiding unnecessary consumption and promoting digital communication.
- Implement composting for organic waste (e.g., food from the canteen).
- 2. Energy Conservation

- 3. Water Conservation
